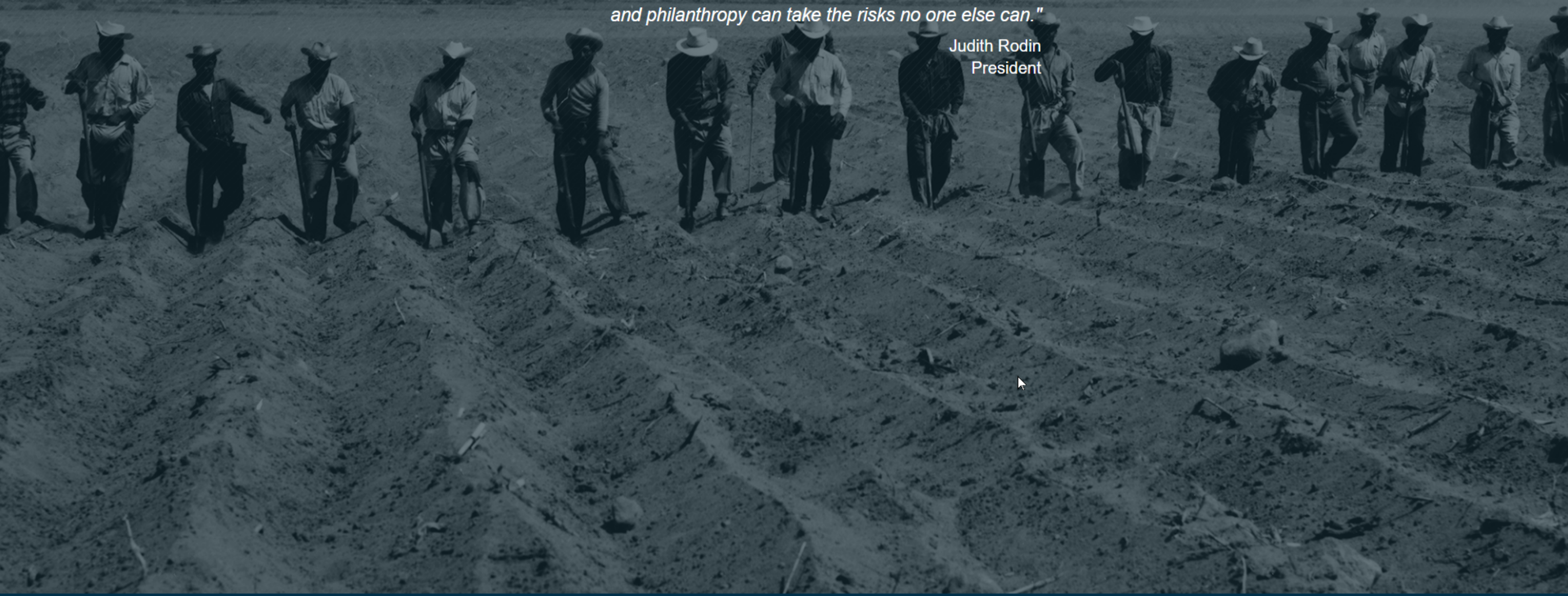

PRESIDENT'S LETTER

INNOVATION FOR THE NEXT 100 YEARS

In a world of constant change, a Centennial is a rare and tremendous milestone. In 2013, The Rockefeller Foundation marked ours with both reflection and celebration, under the banner of our Centennial theme, "[Innovation for the Next 100 Years](#)."

Over the course of the year, we held convenings on issues important to our future in places meaningful to our past. To pay tribute to, and better understand, our rich history, we commissioned a series of books and an interactive website of stories, photos, memos and journal entries from our archives. And we launched a refreshed strategy model that we believe best positions The Rockefeller Foundation to fulfill its mission to "promote the well-being of humanity" for a new century. As part of this refresh, we defined our dual goals—to build resilience and promote inclusive economies—and re-imagined our four focus areas: [Advance Health](#), [Revalue Ecosystems](#), [Secure Livelihoods](#), and [Transform Cities](#).

Against this backdrop, the 2013 Centennial Annual Report focuses on the innovations that made our first century—and our Centennial year—so remarkable: from the launch of the field of public health in the early 20th century to the launch of [100 Resilient Cities](#) in 2013. All of the stories highlighted reflect an innovation in product, partnership or process. Some are already showing impact today—for example, the [Asian Cities Climate Change Resilience Network's](#) work with Asian cities to build resilience to climate change—while others, such as our new initiative [Digital Jobs Africa](#), are in earlier stages. But they all have innovation at their heart and the potential for great transformations.

With the Centennial year now in our rear-view mirror, we have not hit the brakes; rather we have accelerated our pace to find and fund the best new ideas, expanded and deepened our networks for innovation, and re-animated our culture of innovation across our global office locations in New York, Nairobi, Bangkok, and Bellagio.

And so we invite you to look back, and then forward, through the lens of our 2013 Centennial Annual Report. You'll find a [timeline](#) for the year that was, information on the [Strategic Goals](#) that guide all of our work, and inspiring stories of the work in our four [Focus Areas](#). In particular, I hope you'll take the time to read over the lists of our [grantees](#), [staff and board members](#); they are the true heroes of this work, and I'm so grateful to them, and to everyone who will make our second century as effective and as innovative as our first. It is an honor to be leading the Foundation as we launch our second hundred years.

STRATEGIC GOALS



MEET THE CHIEF RESILIENCE OFFICERS



Patrick Otellini (San Francisco, US)

After serving as San Francisco's first "earthquake czar" – in a city with a 67 percent chance of facing a major earthquake within the next 25 years—Patrick Otellini's portfolio was broadened to encompass all resilience building efforts, and making him the world's first CRO.



Christine Morris (Norfolk, US)

A former executive at the Hampton Roads Community Foundation, Christine Morris is poised to take Norfolk's efforts to build resilience to the next level by initiating interdisciplinary teamwork and spearheading a project for flood protection—especially in light of looming threats of sea level rise and flood risk.



Oscar Santiago Uribe Rocha (Medellín, Colombia)

Before being named as Medellín's first Chief Resilience Officer, Oscar Santiago spent half his life—beginning in 1997 with an exchange study program—traveling between Colombia and South Africa, serving as a conduit for ideas and innovations between the two countries. In the course of this work, he met and learned about resilience from leaders like Nelson Mandela and Archbishop Desmond Tutu.



STRATEGIC GOALS



An early leader in the study and practice of resilience, The Rockefeller Foundation has committed more than a half-billion dollars to help cities and communities of all kinds build their economic, social, and climate resilience. These investments include work and pre- and post-Sandy New York, post-Katrina New Orleans, rapidly growing Asian cities, and agricultural innovations in African countries.

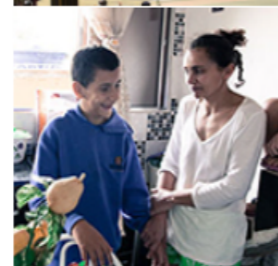
To move this work forward, the Foundation launched 100 Resilient Cities, dedicated to helping 100 cities become more resilient to the crises that are a growing part of the 21st century. Each selected city will receive funding to hire a leader to serve in a new, innovative position: a Chief Resilience Officer, or CRO—a top-level manager, reporting to the mayor, tasked with building and leading a resilience strategy for his or her city. Given the challenges and opportunities of our rapidly globalizing, disruptive, and complex world, The Rockefeller Foundation works to advance inclusive economies that expand opportunities for more broadly-shared prosperity, especially for those facing the greatest barriers to improving their well-being.

To that end, The Rockefeller Foundation has been an early pioneer in the movement for innovative finance as a critical tool for leveraging private capital for public good and creating more inclusive economies. The Foundation funded nearly \$50 million to build the impact investing field and develop the evidence-base for program-related investments. In 2013, innovative finance experienced a groundswell of engagement from governments, nonprofits and private enterprise stakeholders. JANUARY—NEW SURVEY SHOWS IMPACT INVESTING GAINING STEAM

JP Morgan and the Global Impact Investing Network (GIIN) release a report "[Perspectives on Progress](#)" on the promising nature of impact investments. The survey of 99 managers of impact funds revealed that investors planned to commit an estimated \$9 billion in impact investments in 2013, a \$1 billion increase from 2012.

Nearly three-fourths of the world's population is expected to live in cities by 2050. This rapid urbanization brings opportunities but also new threats to health and economic well-being, and, with many cities located in fragile ecosystems, puts more people at risk of climate change impacts and other shocks and stresses.

The Rockefeller Foundation takes a systemic approach to tackling issues that influence cities, including climate change, economic opportunity, social cohesion, sustainable infrastructure, and equitable transportation, to ensure that cities continue to be places of enormous opportunity and growth. Over the last several years, prompted by the 2008 financial crisis and political gridlock at the national level, many local governments have created coalitions of business leaders, civil society members, and urban planners to spark job creation and catalyze long-term economic growth.

The [Brookings-Rockefeller Project on State and Metropolitan Innovation](#), which marked its third year in 2013, is working to help states and metropolitan regions, including Chicago, the Pacific Northwest, Northeast Ohio, and Colorado, lead on innovative solutions to build a new economy. In June 2013, with support from the Rockefeller Foundation, The Brookings Institution's Bruce Katz and Jennifer Bradley published [The Metropolitan Revolution](#) highlighting many examples of some of the most promising metropolitan-led transformations around the country. DIGITAL JOBS AFRICA

It's called the "youth bulge"—by 2050, Africa will have a larger working age population than India and China combined. This will be a challenge if job creation doesn't keep pace: the economics and social consequences could negatively impact an entire generation. But by leveraging trends like the massive growth of the information communications technology (ICT) sector—and innovation in how stakeholders work together—The Rockefeller Foundation sees an opportunity for a better future.

To achieve this impact, in May 2013, The Rockefeller Foundation launched Digital Jobs Africa, a seven-year, \$100 million effort to improve a million lives by connecting high-potential youth in Egypt, Ghana, Kenya, Morocco, Nigeria, and South Africa to sustainable digital employment opportunities and skills training. To reach this ambitious goal, The Rockefeller Foundation is working to bring together a variety of stakeholders and partners, from socially-conscious outsourcing service providers, skills trainers, African and multinational businesses, and governments.

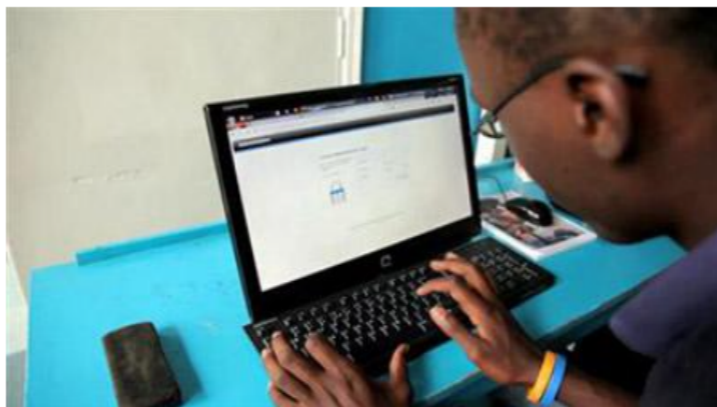

SERVICE PROVIDERS: DIGITAL DIVIDE DATA

Lori Silverstein had a successful, 15 year career at a business processing outsourcing (BPO) firm in Kenya. But after becoming curious about why the company where she worked was losing deals to another service provider in Cambodia, she saw the opportunity presented by “impact sourcing”—an arm of the business processing outsourcing field through which companies intentionally hire firms located in low-income or otherwise disenfranchised areas to do work like database management or data transcription.

Lori saw the opportunity to join the growing impact sourcing movement by becoming chief sales officer at [Digital Divide Data](#), a nonprofit organization that provides data processing, advanced analysis, and content services to clients such as Harvard University, Stanford University, and Ancestry.com. With offices across Cambodia, Laos, and Kenya, the organization’s 1,000 workers also receive education subsidies, enabling them to earn an income while developing their professional skills.

SKILLS TRAINING PROVIDERS: THE IMPACT SOURCING ACADEMY

The growth of the ICT sector in Africa has created a new wave of educational opportunities for young people seeking employment. The Impact Sourcing Academy, launched in Johannesburg, trains unemployed youth to take advantage of jobs available in the growing South African call center industry and business process services sector. As of 2013, 977 unemployed youth have been trained, with 627 already placed among 22 different employers.

AFRICA-BASED COMPANIES AND MULTINATIONALS

"Impact sourcing" is already becoming a boon to corporations that serve as the primary buyers of outsourcing services. The consulting firm Deloitte used the practice in South Africa to hire previously unemployed workers, discovered a sustainable model for sourcing new talent from disadvantaged backgrounds, and achieved greater diversity and lower costs.

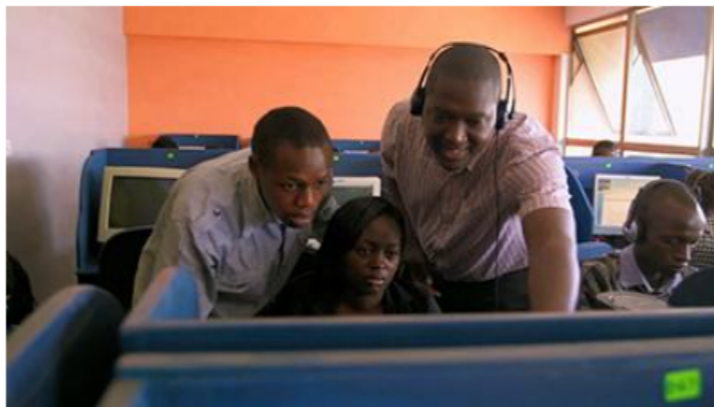

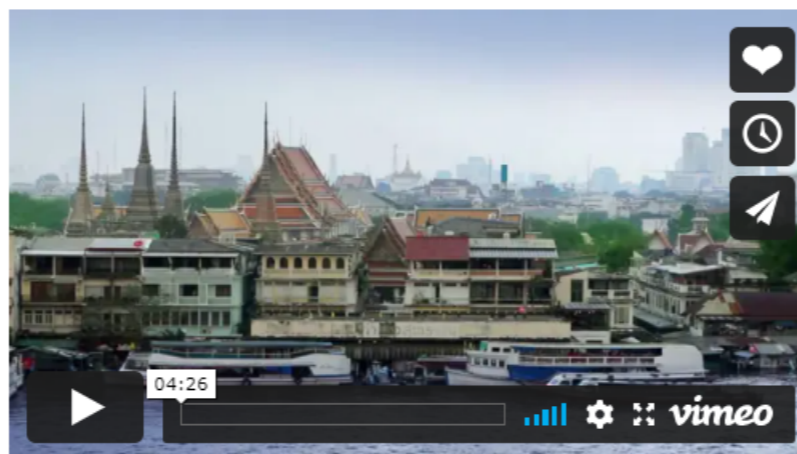

TO SOLVE COUNTRY-SPECIFIC HEALTH PROBLEMS



In 2009, country experts and leaders in global health came together to discuss new opportunities for collaboration and exchange for countries looking to achieve universal health coverage (UHC), which provides basic health services without financial hardship. The Joint Learning Network (JLN) was born from these conversations, and with early leadership and key support from The Rockefeller Foundation, today more than a dozen countries are sharing ideas and best practices.

The real innovation behind the JLN is that unlike most other networks that are run or at least are heavily influenced by a donor agency, the JLN is steered by the member countries who define the JLN agenda and perform most of the work themselves. In this video, learn how this approach has brought together practitioners from Ghana, Vietnam, Nigeria, and other member countries to implement health accreditation programs that evaluate a health care institution's systems, processes, and performance.

SURAT'S CLIMATE CHANGE RESILIENCE JOURNEY

The city of Surat is the most flood-prone city in the Indian state of Gujarat. In 2006, rains were so intense that floodwaters caused \$4.5 million in damage and affected 3.5 million people.

But things are changing. Since joining The Rockefeller Foundation's [Asian Cities Climate Change Resilience Network \(ACCCRN\)](#) in 2008 and [100 Resilient Cities](#) in 2013, the city has worked to develop an innovative strategy that equips them to better prepare for—and bounce back from—future floods. EARLY FLOOD WARNING SYSTEM

One of the most pressing concerns Surat addressed in its resilience strategy addressed was how to protect residents, many of whom are very poor, in the path of the dam's overflow. With ACCCRN's help, Surat formed the Surat Climate Change Trust, a group composed of stakeholders from across the city's business and civic life to design and implement an end-to-end early warning system. The system draws from hydrological modeling on an almost real-time basis and communicates potential risks to vulnerable communities. Now, residents in these communities receive notice at least four days before floodwaters come, giving them enough time to protect their property and evacuate if necessary. The new modeling information will also help the city better plan for building future homes.

Floods aren't the only climate-related risk that the people of Surat face: as in many places around the world, extreme heat has become a looming threat, negatively affecting workforce safety and productivity, as well as general public health. Surat is working to develop low-cost methods for managing this challenge, including a Cool Roof Project that uses simple technologies like thermatite, Chinese mosaic, and broken earthen pots to increase insulation and ventilation, bringing down both temperatures and household costs associated with electricity and water.

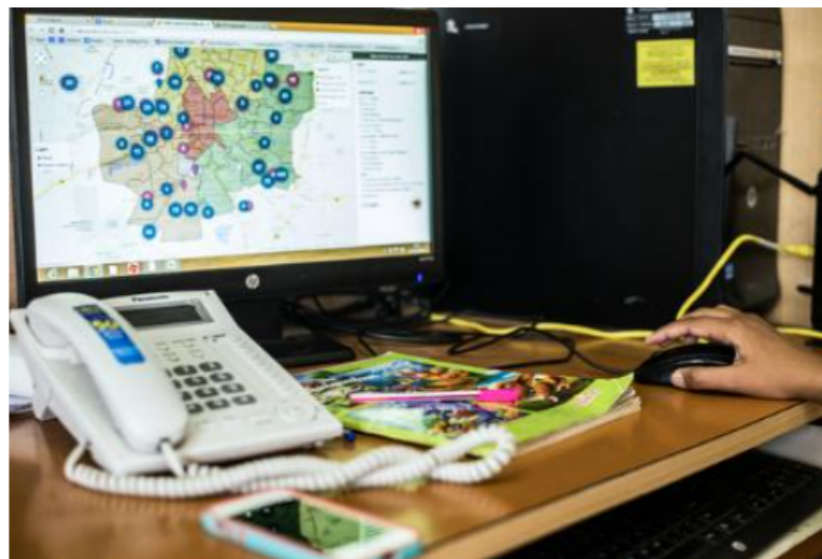

ACCCRN also helped the Surat Municipal Corporation access SMS-enabled near real-time health data, enabling the city's health department to anticipate and prevent the spread of potential disease outbreaks. A new climate and urban health research center, the first of its kind in the region, is conducting cutting edge research on climate and health issues, which will help inform more effective health services in the face of climate change.

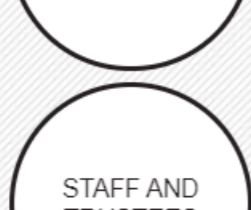
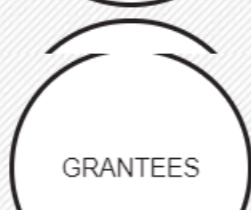
Surat's government has taken real steps to reorganize itself around resilience strategies. The City has dedicated part of its budget to resilience-related activities and involved decision-makers at the highest levels. In March, just before monsoon season begins, Surat's major stakeholders gather with other district collectors, personnel from the three state irrigation departments, private industry players, academics, and officials from the Central Water Commission to consider essential questions: What has changed in the past year? What new farming operations or factory facilities have come online? What new factors might affect the flow of water into the dam and along the river's route? They are then able to change approaches, if needed, to prepare for the season to come.

Created in November 2012 by New York Governor Andrew Cuomo in the aftermath of Superstorm Sandy, the Commission was tasked with finding ways to improve the resilience of the state's infrastructure in the face of natural disasters and other shocks.

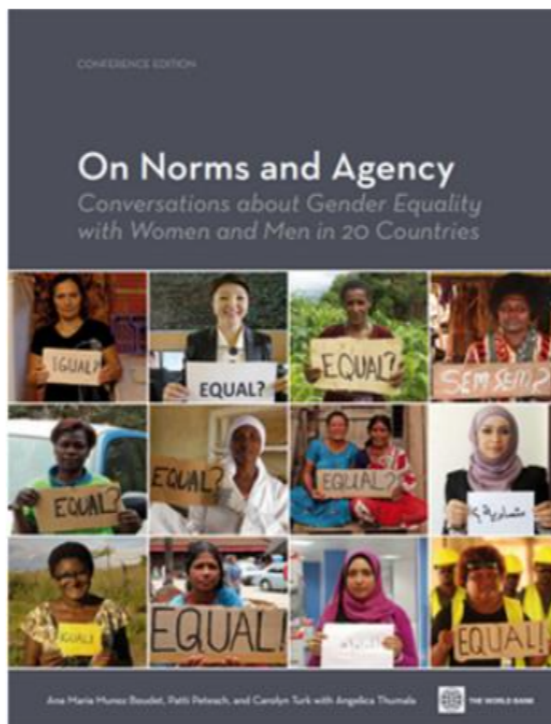

The Rockefeller Foundation announces a \$1.2 million grant supporting local efforts to establish [Bus Rapid Transit \(BRT\)](#) systems in New York City, Boston, Chicago, Nashville, and Pittsburgh. BRT delivers the permanence, speed, and reliability of rail systems, along with the flexibility of bus systems, for a fraction of the cost of rail. BRT also has the double benefit of providing residents in underserved communities access to economic centers, while bringing new sources of revenue and economic development to these areas.

The Rockefeller Foundation announces 10 winners of the 2013 [Centennial Innovation Challenge](#), a competition calling for new innovations and ideas to transform the lives of billions working in informal economies across the globe. People submitted more than 2,260 ideas from 124 countries. Winning innovations included a SMS technology that enables access to micro-insurance, a mobile platform that enables smallholder farmers to connect to markets, and improved access to health care for informal workers.

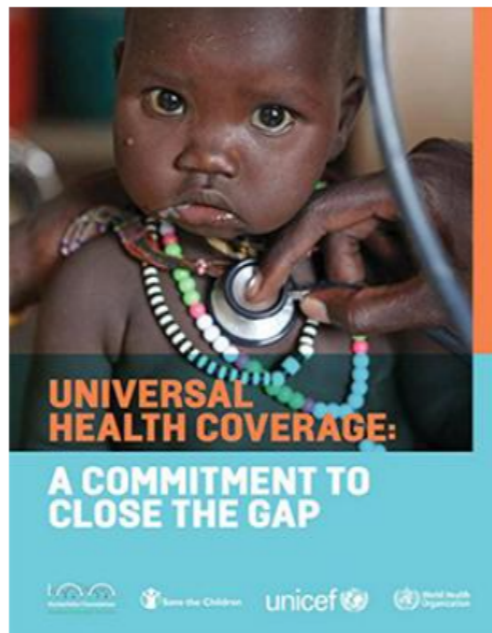
